## Introduction

The fields of public administration and public policy may intersect and complement one another. This dual-degree program provides students with the opportunity to focus on public policy issues while learning administrative skills necessary for success in variety of public service settings. #### Admission

### **Program Delivery**

 Courses are offered on campus, online, and in remote and hybrid formats.

## **Program Requirements**

- 1. Students are required to take 16 courses, or 48 semester hours, to complete the dual degree.
- Students without pre-service experience in the government or nonprofit sectors will also be required to take a three-credit internship course, brining the total number of semester hours to 51.
- Students must earn a minimum of B- grade in each required course applied to satisfy degree requirements and must maintain a 3.0 cumulative GPA.
- No more than six semester hours of Independent Study may be applied towards the degree.
